The Government of Nepal [Bhotekoshi Rural Municipality] has allocated funds from GoN towards the cost of Construction of Bailey Bridge over Bhotekoshi River and intends to apply part of the funds to cover eligible payments under the Contract Construction of Bailey Bridge over Bhotekoshi River (10km to bokchen road), Contract ID No: NCB/BRM/WORKS/12/080/081 Bidding is open to all eligible as per Section V of bidding document.
2. Bhotekoshi Rural Municipality invites electronic bids from eligible bidders for the construction of Construction of Bailey Bridge over Bhotekoshi River (10km to bokchen road) under National Competitive Bidding - Single Stage Two Envelope Bidding procedures.

**Only eligible bidders with the following key qualifications should participate in this bidding:**

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 49900000.00/-
- Minimum Work experience of similar size and nature: One(1) Bailey Bridge/Steel Truss Bridge/Steel Plate Girder Bridge worth NRs. 15600000.00/-

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

7. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 Hrs. on 2080/11/13 (25th Feb 2024). Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hrs. and 2080/11/13 (25<sup>th</sup> Feb 2024) at the office of Bhotekoshi Rural Municipality, Sindhupalchok. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs.1100000.00, which shall be valid for 30 days beyond the validity period of the bid. **Information to deposit the cost of bid security in Bank :**
