1. The Bhotekoshi Rural Municipality [BRM] has allocated funds from BRM towards the cost of Dumithang Dugunagadi Road Upgrading & Maintenance and intends to apply part of the funds to cover eligible payments under the Contract for NCB/BRM/WORKS/13/080/081
2. Road Upgrading & Maintenance, Contract ID No: NCB/BRM/WORKS/13/080/081. Bidding is open to all eligible bidders as per Section V of bidding document.
3. Bhotekoshi Rural Municipality invites electronic bids from eligible bidders for the construction of Dumithang Dugunadagi Road Upgrading & Maintenance under National Competitive Bidding - Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 32,382,300.00

Minimum Work experience of similar size and nature: NRs. 8,755,300.00

4. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
5. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Bhotekoshi Rural Municipality, Phulpingkatti, Sindhupalchok or may visit PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
6. Bidder must submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document NRs. 5,000.00 in the Project's Rajaswa (revenue) account as specified below.

7. Pre-bid meeting shall be held at Bhotekoshi Rural Municipality, Phulpingkatti, Sindhupalchok at 12:00 Hrs & 2081/02/09 (22<sup>th</sup> may 2024).
8. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 Hrs. on 2081/02/20 (2<sup>nd</sup> June 2024). Bids received after this deadline will be rejected.
9. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hrs. and 2081/02/20 (2<sup>nd</sup> June 2024) at the office of Bhotekoshi Rural Municipality, Sindhupalchok. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 645,000.00, which shall be valid for 30 days beyond the validity period of the bid (120 days from the date of bid opening).
10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
